

Qualifications and Guidelines



Customers must complete 12 qualified presentations* within 180 days from the date of sale, with at least 2 of the shows resulting in a "1st line sale," and complete 6 of the 12 presentations within 45 days from the date of sale to receive the bonus of \$3000 after the completion of the 12th qualified show. A 1st line sale is defined as a full-price Rainbow (SRX Model) that has been approved by the finance company with a 1st line approval (A, B, C) rating or paid cash, credit card, or cheque. A sale must be considered "1st line" to qualify for promotions of any kind. If any sale is financed as a 2nd (D, E, F, G, H) or 3rd (Special handling) line of approval, no promotions of any kind will be paid. Customers that do not complete 6 presentations within 45 days will have their promotional earnings reduced to \$1500. Customers that have financed their Rainbow will have funds forwarded to the finance company on their behalf to be applied to their account balance. All cash, credit card or cheque customers will receive a cheque. All payouts will be considered Promotional Giveaways and treated as such.

All promotions will be paid once Rainbow has been paid by the finance company and the finance company has received the first payment by the customer. Allow up to 8 weeks to process promotional cheques. Promotion cheques are only earned on 1st line sales and only when the date of the show and date of the sale match.

If a customer fails to follow the guidelines of the program or Rainbow determines that they are being uncooperative, that customer will be ineligible to continue and will forfeit any and all commissions earned.

BY INITIALING, I AM STATING THAT I FULLY UNDERSTAND THE TERMS AND CONDITIONS OF THE PROMOTIONAL CHEQUES AND COMPLETELY UNDERSTAND THE TERMS "1ST LINE SALE" AS DEFINED ABOVE.

I understand that the "go-for-GOLD" program and the gift program are transactions separate and apart from the purchase of my Rainbow cleaning system and have no bearing on the validity of any "retail installment agreement" or other contract signed in the connection therewith. I fully understand that I am obligated to pay my monthly payments whether or not I earn the separate items offered by the special. I must honor the terms of my "retail installment agreement" if I choose to do the "go-for-GOLD" program, I understand the promotions earned will be forwarded to the finance company on my behalf.

I am responsible for ALL sales taxes and interest (government taxes, sales tax or any interest accrued) If at any time this program is changed, I am not eligible to switch programs. If a gift offered is no longer available, it may be replaced with one of equal value. I understand that the "gift" program consists of extra accessories that may only be obtained through separate purchase or by completing the required presentations. These attachments include but are not limited to Aquamate, Rainjet Complete, Minijet, Rainbowmate, any fragrances/disinfectants, and/or supplies sold separately.

BY INITIALING, I AM STATING THAT I FULLY UNDERSTAND THAT WHETHER OR NOT I DECIDE TO PARTICIPATE IN THE "GO-FOR-GOLD" PROGRAM, IT IS MY RESPONSIBILITY TO PAY FOR MY RAINBOW SYSTEM

This agreement superseded any/all other agreements and constitutes the entire and only agreement between parties. Other than your original purchase of the Rainbow, which is your responsibility to pay.
